FOOD VENDOR CONTRACT

- DATE:** Saturday, October 1, 2016 and Sunday, October 2, 2016
IMPORTANT: You must be present both days unless previously agreed upon or you will not qualify to enter in future shows!
- HOURS:** 11:00 A.M. to 5:00 P.M.
- PLACE:** Farnsworth Avenue, Bordentown City, from Burlington Street to Park Street (both sides).
- BOOTH SPACE:** Space size 12'x10'. Bring your own tables, tent, etc. Spaces are limited; apply early.
- COST:** \$250. For each 12'x10' space. If your equipment requires more than a 12'x10' space, please state the size of your display and enclose the correct fee. The signed contract and payment of \$250 must be returned as soon as possible. Secured overnight spaces are available for an additional \$100 fee.

ASSIGNMENTS: You will receive a space assignment by mail approximately two weeks before the Cranberry Festival.

There will be a fire marshal inspection Saturday morning. Instructions are enclosed.

1. Please display at your booth your NJ Sales Tax Authorization form.
 2. No alcoholic beverages.
 3. No distribution of printed material unless exhibitor-related.
 4. Table dismantling must begin promptly at 5:00 P.M. to allow street sweeper access.
 5. NO GENERATORS.
 6. All food vendors must comply with NJ Board of Health regulations.
 7. Must have on-site fire extinguisher.
 8. Everyone must break down Saturday night except those who have paid for a secured overnight space.
 9. Political campaigning is prohibited.
